APPENDIX A

Goals of DSDA Blue Suede Shoes

It is the goal of DSDA Blue Suede Shoes to be an Association for everyone passionate about dancing. We also want to give people a platform to express and develop their creativity, as well as to advance their skills, by facilitating practices and guest teachers. We also want to give our members the opportunity to socialise with other like-minded dancers by facilitating parties and monthly meetings/dance gatherings.

Activities DSDA Blue Suede Shoes

DSDA Blue Suede Shoes aims to offer engaging activities for its dance members. Currently, the following activities will be offered:

- DSDA Blue Suede Shoes hangouts. Members can meet once or twice a month at a social event with different activities.
- Free hour(s) a week for dance practice
- Technique classes for two different dance styles.
- DSDA Blue Suede Shoes parties for free.
- Together, we visit other parties in the region.
- Highly discounted workshops for all different levels and dance styles.

Membership fee

- Student (Bachelor/Master/TU-Delft PhD): Full-year for 60€, semester for 30€
- General (any other member of BSS): Full-year for 80€, semester for 40€
- You must purchase an X subscription separately to join regular activities (practices and classes) hosted at X TU Delft. You are allowed to attend parties organised at X without an X subscription. If you have an X subscription for the full period of your being a BSS member in the academic year, your full-year membership will be reduced by 30€ (or your semester membership will be reduced by 15€)
- The membership fee will be collected yearly, and you will be notified in advance by email. The membership fee is subject to change as decided in the GMA.

Membership cancellation

Membership is subject to the house rules and articles of association. Your membership will automatically renew each academic year (or each new semester for semester memberships), unless you unsubscribe. If you want to unsubscribe, you must inform the Board in writing (info@dsda.nl) by the 1st of August. The Board can make exceptions to cancel memberships during the academic year if good reasons are provided. Temporary unsubscription when leaving for a semester abroad or for any other reason is also possible.

APPENDIX B

Terms of Agreement concerning the Membership fee

- Term 1: The member pays a yearly or half-yearly membership fee.
- Term 2: The amount of the membership fee is determined by the member's relationship to the Delft University of Technology, the duration of the membership, and the X subscription status.
- Term 3: The member agrees to pay for at least one membership term upon signing the contract. Membership period options:
1. 1st of September till the 31st of August
 2. 1st of February till 31st of August
 3. 1st of September till 31st of January
- Membership begins when a Board member signs the contract. If this is not the case, the member will not be able to participate in members-only DSDA Blue Suede Shoes activities and will not get discounts to DSDA Blue Suede Shoes events.
- Term 4: The member will be notified when the membership fee is collected.
- Term 5: Disagreement about the collected membership fee must be communicated to the Treasurer of DSDA Blue Suede Shoes within seven days.
- Term 6: To apply for either the back transfer of the membership fee or the rectification of the collected membership fee, the member must have satisfied Term 5, and a reason must be shown for the back transfer or rectification.
- Term 7: The membership fee will be collected once per membership period, in one or two instalments via electronic banking. Exceptions to the payment method can be made if electronic banking is not possible.
- Term 8: The collection of the membership fee will recur in each subsequent membership period unless the member prematurely notifies DSDA Blue Suede Shoes of the termination of their membership.
- Term 9: A request to terminate the membership must be submitted in writing, including the member's personal data and the reason for termination, by the 1st of August.
- Term 10: If the member does not unsubscribe in accordance with Term 9, Term 8 will apply.
- Term 11: Any increase in the membership fee will be announced at the 'ALV' (Algemene Leden Vergadering - General Members Assembly). After ALV approval, this increase will no longer be open to debate.
- Term 12: The member is obligated to acknowledge the aforementioned Terms 1-12.
